- Agree that Fidelity will not be liable for any loss, liability, cost, or expense for acting upon all instructions believed to be genuine if Fidelity employs reasonable procedures to prevent unauthorized transactions.
- Agree that (1) this authorization may only be revoked by written notice to Fidelity in such time and manner as to afford Fidelity a reasonable opportunity to act upon it and (2) Fidelity may terminate this Standing Transfer Instruction at any time in its sole discretion.

A Medallion signature guarantee is required.

If the form is completed at a Fidelity Investor Center, the Medallion signature guarantee is not required. You can get a Medallion signature guarantee from most banks, credit unions, and other financial institutions. **A notary seal/stamp is NOT a Medallion signature guarantee.**
